1. All the above selected candidates are awarded a Government of India fellowship @ Rs. 5,000/- (Rupees five thousand only) per month. There are no other allowances.
2. All the selected candidates shall be allotted a Hostel accommodation within the Institute's campus on sharing basis at subsidized rate.

3. The offer of admission is provisional subject to candidates producing their original certificates, testimonials, final year mark sheets of qualifying examinations and provisional/degree certificate at the time of admission for verification of age, subject, caste etc. as notified in the admission announcement.
 4. All the selected candidates must confirm their acceptance of this offer in writing or by email before 5.00 p.m. by 16th March 2019.
 5. Admission of those candidates who fail to remit their fees online by 18th March 2019, 5.00 p.m. shall stand cancelled and the vacant seat shall be offered to the next eligible candidate/s as per rule. No communication or correspondence of any sort from the defaulters shall be entertained.
 6. All the selected candidates are required to join on the opening day of the programme, i.e. 1st July 2019, failing which the offer stands cancelled.
 7. Candidates belonging to SC/ST/PWD category must produce valid caste /PWD certificate issued by the competent authority, at the time of admission.
 8. In case of candidates selected under OBC category must produce recent/valid "Non-Creamy Layer" certificate issued by the competent authority and their caste of claim must be valid in accordance with the castes of central list published by the Government of India, at the time of admission. Else, the offer stands cancelled.
 9. Candidates awaiting results of qualifying examinations are required to submit their final mark sheets latest by 30th September 2019 failing which their admission shall stand automatically cancelled.

Candidates must remit their fees online on or before 18th March 2019 and submit a copy of payment receipt to the Academic Section at the time of admission.
