The Committee further recommends that those candidates who have been "provisionally shortlisted" be intimated in advance (i.e., prior to the written test/other process as approved by the competent authority) with regard to the documents to be produced at the time of appearing for further process for recruitment, in support of their eligibility for the said post and that these candidates would be permitted to write the written test subject to production of documents and acceptance by IIPS.
