The "International Institute for Population Sciences", Mumbai is a 'Deemed University' under Section 3 of University Grants Commission Act, 1960 and is functioning under the administrative control of Government of India, Ministry of Health and Family Welfare (MoHFW). MoHFW has designated the **International Institute for Population Sciences (IIPS) as a national nodal implementing agency to conduct the National Family Health Survey (NFHS)-4 project** across the country with the help of selected Field Agencies.

IIPS is in process of printing key finding of NFHS-4 project in the form of Fact Sheets and State Reports for 30 states and one National Report. In this connection sealed tenders are invited on behalf of Director, IIPS, Mumbai from reputed printer for printing of following documents:-

Terms and conditions:

1. Processing Fees is Rs. 2500/- (Non Refundable) and EMD is Rs. 30,000/- (Refundable)
2. Processing fees and EMD are to be paid by two separate demand drafts issued in favor of Director IIPS, payable at Mumbai at the time of submission of bid/tender documents.
3. Bids/ Tender documents should be submitted to The Director, International Institute for Population Science, Govandi Station Road, Deonar, Mumbai 400088.
4. Bids/ Tender documents received upto 1.30 pm 15st June 2017 will be considered.
5. The tender will be opened on 21nd June 2017 at 3.30 pm.
6. Successful bidder will be required to submit performance security of 5% of total contract value in the form of account payee demand draft or bank guarantee from a nationalized bank and/or a bank recognized by the RBI.
7. Such performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations.
8. EMD in case of unsuccessful bidder will be refunded within 15 days of opening of tender.
9. EMD in case of successful bidder will be refunded after receipt of performance security.
10. Evaluation committee may visit the short listed printers to verify their physical infrastructure before awarding of contract.
11. Financial bid and other necessary documents should be submitted in individual separate sealed envelope, which shall again be put in a duly sealed envelope super scribing “ Bid for Printing State Reports and National Report for NFHS-4”

Pre-condition for opening of financial bid:

1. Proof of working experience of at least five years of printing of books/reports.
2. Annual turnover of Rs. 25 lakhs in each of last 3 years (2013-14, 2014-15, 2015-16) as per audited financial statements.

Payments conditions:

1. Payment will be made by IIPS NFHS-4 within 30 days of receipts of reports upon submission of invoice in duplicate subject to verification of work by coordinators of NFHS-4 project.
2. Payment will be made by a cross cheque /NEFT/RTGS after deduction of TDS subject to audit by the accounts department.
3. Payment can be released on completion of state report on staggered manner.
4. In case if any dispute arising out of these tender documents, the decision of the Director, IIPS shall be final and binding on bidders.
