**MINUTES OF THE MEETING OF MEMBERS OF CENTRAL GOVERNMENT EMPLOYEES WELFARE CO-ORDINATION COMMITTEE (CGEWCC) HELD ON 28.10.2015 AT 3 PM AT ROOM NO. 374, AYAKAR BHAVAN MUMBAI**

The Annual General Meeting of the members of CGEWCC commenced at 3 PM on 28.10.2015. The representatives of various Central Government Departments situated at Mumbai as per Annexure-I attended the meeting.

The meeting was chaired by Chairman of the Committee Dr. B. Senthil Kumar, Commissioner of Income Tax (Admn & Co). The General Secretary Shri Ritesh Mishra, Additional Commissioner of Income-tax, Joint Secretary Shri Padmakumaran C. and Dr.Devananda R, CMO on behalf of Addl. Director, CGHS, Mumbai attended the meeting.

Shri Ritesh Mishra, General Secretary welcomed all members of the Committee. Nearly 35 members from various Govt. Depts. attended the meeting.

As per the agenda the following issues were discussed:

**1. HOLIDAYS FOR THE CALENDAR YEAR 2016**

One of the main items of agenda was selection of 3 holidays in the State of Maharashtra for the calendar year 2016. Considering the majority suggestion of all the Government Departments, following three holidays were approved by the Chairman and the members present in the meeting:

As regards Restricted Holiday, Shri Mouizn Hussain, representative from NIC has suggested to include Hazrat Ali in R.H. list.

**2. Medical issues:**

Extensive discussions/debate took place as representatives had various views and grievances related to treatment and reimbursement. Some of the important issues are as under :

- i. Most of the members informed that last year, it was suggested for setting up of sub-committee to follow up the matter in every area but unfortunately that has not been happened. Therefore, during the meeting itself, a sub-committee was formed with the following members to meet atleast twice in a year to pursue various medical grievances, empanelment of hospital etc. and communicate it to all members:

The next meeting of sub-committee formed for medical is fixed on 20/1/2016 at 3 p.m.

ii. The members informed that the eligible rates for various medical treatments specified in the Schedule of CGHS are based on the rates for hospitals situated in New Delhi. However, the rates charged by hospitals in Mumbai are much higher than the rates mentioned in the CGHS Schedule. This causes hardship to CGHS beneficiaries as they are not eligible to get full reimbursement of the medical expenses. In the meeting it was decided to make a survey of rates charged by various Hospitals in Mumbai and compare the same with the rates specified in the Schedule and send the same to Ministry of Health and Family Welfare, New Delhi for necessary action.

iii. The members also demanded for good hospitals such as Jaslok Hospital, Bombay Hospital to be included in the panel of CGHS as there are no hospitals for South Mumbai in the panel at present. In Delhi there are so many panel hospital whereas in Mumbai, number of panel hospital is limited. The members discussed that in Delhi, rate list of 2014 is going on, whereas in Mumbai, we are still following the rate list of 2011. Regarding this, CGHS representative has clarified that since there is no name of Mumbai in the list and also some case is pending before the court, list of 2011 is to be followed.

iv. The members also voiced against non-mentioning of expiry date on medicine strips, non-availability of proper prescription etc. The members also stressed for timely issue of plastic card which is delayed beyond limit.

As the above issues related to CGHS and Addl. Director, CGHS, Mumbai was not present due to his pre-occupation on account of DPC meeting, it was unanimously decided to forward the above grievances to CGHS for necessary resolution.

vi. Tariff Authority representative said that theirs being Autonomous Body are in great problem as they are neither in CGHS nor CSMA, hence matter should be taken into account very seriously.

vii. The members further discussed that the present monetary limit of HOD for granting funds towards medical reimbursement is Rs. 2 lakhs only and members suggested that it should be increased to Rs. 5 lakhs so that medical bill can be settled at our level. The Chairman was of the opinion that a letter seeking enhancement should be written by the Committee to the Health ministry. All the members attended authorized the Welfare Committee to send the letter to Health Ministry.

3. Jurisdiction of area covered by Ambernath Wellness Centre: A majority of members stated that the CGHS Wellness Centre at Ambernath is not at all accessible to the employees staying outside Ambernath though it caters the areas of Ulhasnagar, Badlapur and Shahad Municipalities. It was also stated that the same is located more than 8 kms away from the residential areas of Ulhasnagar, Badlapur and Shahad and it is practically impossible for the persons to visit the Wellness Centre every time as it is time consuming and expensive. Hence they have requested to open new CGHS dispensaries in these areas or continue the facility of AMA till that time. The Addl. Director informed that all the medical issues will be discussed in forthcoming meeting on 20/1/2016.

4. **Annual Medical Examination Facility:** At present this facility can be availed by Class I/Gr. A officers only. All the members were of the opinion that this facility should be extended to all categories of government employees. The suggestion was unanimously approved and authorized the Committee to send the above suggestion to DoPT, New Delhi.

5. **Central Govt. Hospital**

The members suggested of opening up of Central Govt. Super Speciality Hospital with all modern facilities for various deceases like Cardiac, Nephrology, ENT, Orthopaedic , etc. etc. under one roof, so that employees need not run here and there for various tests in critical situations.

6. **LAUNCHING OF HOUSING PROJECT FOR CENTRAL GOVT. EMPLOYEES**

A suggestion was made to initiate action for launching of housing project (Kendriya Vihar II phase) in the vicinity of Mumbai Metropolitan Region for the Central Government Employees as welfare measure. The committee members have also agreed to the above suggestion and unanimously decided to explore the possibility of launching housing project exclusively for the benefit of Central Govt. Employees.

7. **REGIONAL SPORTS BOARD MATTER (RSB) :**

A sub-committee for sports including the following members was formed during the meeting to solve various issues in this field :-

Shri Anil Tikare, Secretary, of RSB along with Shri Linesh Phatak, Treasurer of RSB and Shri Virendra Pednekar, Asstt. Secretary (Sports – Indoor) brought to the notice of the Chairman and Committee Members that there is no fund available with the RSB, Mumbai. Further, it was stated by the Secretary that Mumbai being costly city and all ground/hall charges are very high, hence, it is impossible to conduct (trials / selection) in so many sports events pertaining to various offices situated in Mumbai. They also informed that the audited report was sent to Delhi, yet fund has not been released from the year 2003-04 onwards. Shri Anil Tikare, Secretary, Cultural & Sports informed that he is in constant touch with Delhi in order to get funds for the Sports Activities, however, there was no response. They were of the opinion that a letter may be issued from the Welfare Committee narrating the above facts. The Chairman directed the General Secretary to look into the matter.
